RESEARCH: CCHR CONDUCTED RESEARCH INTO THE MANY DIFFERENT AREAS OF HUMAN RIGHTS ABUSES IN THE MENTAL HEALTH SYSTEM INCLUDING PSYCHIATRIC DRUG USE WITHIN THE MILITARY AND THE LINK BETWEEN PSYCHIATRIC DRUGS AND SENSELESS VIOLENCE.

CCHR RESEARCHED, PUBLISHED AND RELEASED A 4-PART SERIES ON THE EPIDEMIC OF SUICIDES IN THE MILITARY AND THE CORRELATION TO DRAMATIC INCREASE IN PSYCHIATRIC DRUG PRESCRIPTIONS TO TREAT THE EMOTIONAL SCARS OF BATTLE. IT WAS FOUND THAT FROM 2001 TO 2009, THE ARMY'S SUICIDE RATE INCREASED MORE THAN 150 PERCENT WHILE ORDERS FOR PSYCHIATRIC DRUGS INCREASED 76 PERCENT OVER THE SAME PERIOD.

THE CCHR HOTLINE IS PROMOTED THROUGH ITS PUBLICATIONS, THE MEDIA, PUBLIC SERVICE ANNOUNCEMENTS, ITS WEBSITE AND THROUGH SOCIAL MEDIA. THROUGH THIS HOTLINE CCHR ASSISTED THOSE REPORTING PSYCHIATRIC ABUSES AND FILED COMPLAINTS TO THE APPROPRIATE AUTHORITIES. CCHR ALSO PROVIDED THOUSANDS OF CALLERS WITH ACCURATE INFORMATION OF THE DOCUMENTED RISKS OF PSYCHIATRIC DRUGS AND OTHER DATA THEY NEEDED TO BECOME BETTER INFORMED ABOUT PSYCHIATRIC TREATMENTS. THIS INCLUDED SENDING FREE MATERIALS AND DVDS TO CALLERS THAT REQUEST THEM.

LEGISLATIVE & POLITICAL ACTIVITIES: CCHR'S MISSION IS TO ERADICATE ABUSES COMMITTED UNDER THE GUISE OF MENTAL HEALTH AND ENACT PATIENT AND CONSUMER PROTECTIONS. SINCE ITS FORMATION, CCHR HAS HELPED TO ENACT MORE THAN 150 LAWS PROTECTING INDIVIDUALS FROM ABUSIVE OR COERCIVE MENTAL HEALTH PRACTICES.

IN 2012, CCHR, ALONG WITH ADVOCACY GROUPS AND EXPERTS, CONTINUED TO INFORM AND EDUCATE LEGISLATORS AND POLICYMAKERS ABOUT THE INHERENT DANGERS OF PSYCHIATRIC DRUGS, MENTAL HEALTH TREATMENTS AND PRACTICES.
